Avenues for Giving to CBM

BY CHECK

- 1) Make check payable to Continental Baptist Missions
- 2) Complete the appropriate section of the Financial Support Declaration for the type of donation you are making (recurring support or one-time contribution) as well as your donor information
- 3) Mail completed form and support check to:

Once your check is processed, the CBM business office will issue a receipt letter by US Mail. The perforated portion at the bottom of the letter includes a receipt stub to keep for your records as well as a copy to include with future gifts if you are a recurring support donor.

If in the future you choose to give a gift outside of regular support, please include a note with the check or use the memo line to designate if the contribution is a One-Time Gift, Special Project, and/or the amount designated as a Christmas or Birthday gift.

Regular Support, One-Time Gifts, and Special Project Gifts are taxable to the missionary and the donor will receive a tax deductible receipt.

Donations intended as Christmas or Birthday gifts are non-taxable to the missionary (with the current tax code). As such, the donor will not receive a tax deductible receipt for these designated gifts.
